MINUTES OF THE MEETING UNDER CONVERGENCE TO DISCUSS THE MEMORANDUM OF UNDERSTANDING SIGNED BETWEEN DEPARTMENT OF RURAL DEVELOPMENT, MoRD WITH FISHERIES DEPARTMENT OF MOA & FW ON 22<sup>nd</sup> JUNE, 2017 AT THE SECRETARIAT CONFERENCE HALL AT 1200 HRS.

The meeting was chaired by Pu V. Lalremthanga, IAS, Secretary, Rural Development Department. At the outset, the Chairman welcomed the members and evinced that the meeting was convened as per the instruction of the Ministry of Agriculture & Farmers Welfare, Department of Animal Husbandry, Dairying & Fisheries, vide their letter No.F.No.27035/22/2016-Fy (IV) dated 25<sup>th</sup> May, 2017 requesting the State to deliberate on the scope of MOU for formalizing Convergence and maximize the outcome of the investment under these schemes. After stringent discussion on the issues highlighted in the letter, it was decided that, as a commencing step towards carrying out the spirit of the MoU, the following action would be taken up :

- 1. At the State level, a **State Coordination and Synergy Committee (SCSC)** would be established with the following composition:

**Chairman:** Secretary, Rural Development Department.  
**Co-Chairman:** Secretary, AH & Vety, Fisheries, Agriculture Department.

**Members:** Secretary, Finance; Director, AH & Vety; Director, Fisheries, Director, Rural Development Department; Director, Agriculture; Additional Director, AH & Vety; Joint Director (Planning & Monitoring), Agriculture Department, CEO, MzSRLM.

**Member Secretary:** Additional Secretary, Rural Development Department.

- 2. At the District level, a **District Coordination & Synergy Committee (DCSC)** would be formed with the following composition:

**Chairman:** Deputy Commissioner of the Districts concerned.

**Members:** District Vety Officer, District Agriculture Officer, District Fisheries Development Officer, Block Development Officer concerned.

**Convener:** Project Director, District Rural Development Agency.

- 3. Terms of Reference of the Committees at the State & District would be formulated.

4. On Notification of the Committees at the District level, Action Plan for the current Fiscal Year would be formulated mutually working together in synergizing various schemes of the converging line Departments to achieve the common goal of doubling farmers income through the synergy of efforts in various sub-sector.


The Meeting concluded with a vote of thanks from the Chair.

Terms of Reference of the two-tier Committee shall be :

1. Planning and Coordination to effect Convergence between scheme under taken by Rural Development Deptt., Fisheries, Agriculture, AH & Vety.
2. Address monitoring issues of the converged Schemes and ensure the effective implementation of the Convergence.
3. Formulation of Action Plan of the current Fiscal Year at the District level mutually by the line Department.
4. To achieve a common goal under convergence in doubling farmers income through the synergy of efforts in various sub-sector.
